CORE invests in groups and programs that help the communities we serve.

At our recent Summer Showcase, we held a silent auction to benefit the **Douglas/Elbert Task Force Help & Hope**

Center, a non-profit human service organization that assists people in Douglas and Elbert counties who are in severe economic need, at risk of homelessness, or in crisis. Thanks to the generosity of our Summer Showcase guests, we raised more than \$8,400 for the center.

During that same event, each of our seven elected district directors presented a check to a worthy cause within his district:

- District 1 Director Mike Kempe presented \$7,500 to **Castle View High School**.
- District 2 Director Ron Kilgore presented \$7,500 to the LifeBridge
 Food Pantry, which provides food and other services to those in need in Park County.
- District 3 Director Mike Sperry presented \$5,000 to **Focus on the Forest**, which uses alternative solutions to motivate and enable communities in and around

Woodland Park to keep public lands clean.

• District 4 Director Tim White presented \$7,500 to the **Cherokee Ranch and Castle Foundation**, which seeks to preserve the natural environment, enhance cultural life in

Colorado, and provide educational opportunities related to western heritage, wildlife and the arts.

- District 5 Director Bruff Shea presented \$7,000 to **Elbert County Coalition Outreach**, which helps families become self-sufficient through the development of life skills.
- District 6 Director Bob Graff presented \$7,500 to the Arapahoe County 4-H Youth Livestock Auction, which is dedicated to raising the next generation of agricultural leaders.
- District 7 Director Jim Anest presented \$20,000 to the **Parker Task Force**, which provides Douglas

County families with food, financial aid and other support services. Half of that donation was a matching contribution from **CoBank**, which provides financial services to cooperatives, agribusinesses and other rural infrastructure.

CORE Takes Legal Action to Protect Members

CORE is taking legal action on behalf of its members against Public Service Company of Colorado, a subsidiary of Xcel Energy Inc. Xcel breached its contractual obligations related to the operation and maintenance of the Comanche 3 coal plant in Pueblo, and we have filed a lawsuit in district court.

CORE is committed to providing reliable, affordable power to our members and to protecting their assets. We enter into contracts to protect our members and we take action when necessary to recover unjustified costs imposed upon them or for damage to CORE's assets

CORE only pursued this course of action after many months of attempted business resolution and extensive consultation with our legal and technical advisors.

CORE Proud to Power FarmBox, the Future of Sustainable Farming

FarmBox Foods

CORE Electric Cooperative provides businesses The Energy to Thrive and is proud to power innovative and emerging businesses. One of the most unique businesses we serve is **FarmBox Foods**, which is

just across the road from our Sedalia headquarters.

FarmBox's creative and groundbreaking approach to farming

promises to connect communities with sustainably sourced, locally grown food year-round. Its patented product is a vertical hydroponic farm (VHF) housed within a 320-square-foot shipping container. Each VHF can grow leafy greens, tree saplings, peppers, grape tomatoes and more from seed to harvest. A single VHF yields the equivalent of more than 2 acres of traditional farmland – about 9,000 plants or 35,000 tree saplings per year. Top-of-the-line software called Agrowtek monitors the temperature, humidity and lights.


FarmBox's VHFs are protected against drought, hail, pest, heat waves, freezes and other hazards that often ruin traditional crops, and are less prone to food-borne

illnesses. They also use 90% less water than traditional farms.

CORE is exploring a partnership with FarmBox to grow seedlings for local reforestation. This unique partnership

will help CORE develop a planting program to replace trees damaged by fires or removed to protect nearby power lines.




CORE Begins Rebuild Project in Palmer Lake Area

CORE has begun a rebuild project that upgrades distribution lines in the Palmer Lake area to improve reliability and bring them up to CORE standards.

The upgrade is substantial and will be completed in four phases. The first phase, in the northwestern portion of town, began construction this summer. About 7 miles of line will be replaced across the project's four phases. The anticipated total investment in the project is approximately \$4 million.
