I want to take the opportunity to give you an overview of CORE's past achievements and outlook as the Director seat for District 6 on CORE Electric Cooperative's Board is currently vacant. Per CORE's bylaws, this vacancy will be filled by a majority vote of the remaining board members. The board will review submitted letters and résumés, conduct interviews, and select a qualified individual to serve as District 6 Director. I look forward to working with the new Director, who I am sure will be an excellent representative for District 6.

CORE has achieved a historic milestone by transitioning from our legacy power supplier to a dynamic, diversified energy portfolio that gives us greater control and flexibility, strengthens our foundation for long-term cost stability, and brings us closer to Colorado's greenhouse gas emission reduction goals. This work is accompanied by our outstanding reliability figures, supported by ongoing maintenance and system improvement programs such as cycled pole testing and drone inspections. CORE's financial strength is further demonstrated by our "AA-" Fitch credit rating and the retirement of \$12.25 million in capital credits to our members in 2025. CORE to award grants for graduating high school seniors

Since 1988, CORE's board of directors has awarded **grants to graduating high school seniors who plan to continue their education**. Each year, we award 35 grants — five per director district — of \$2,000 each. Grant recipients are chosen via a lottery-type drawing, as there are no scholastic requirements. The names of five students from each of the seven CORE director districts will be randomly drawn to receive the grants.

The applicant — or applicant's parent or guardian — must be a

CORE member to be eligible. The applicant must also:

- Be a graduating high school senior in 2026;
- Submit an acceptance letter from a college, university or vocational/trade school; and
- Return a completed entry form by 5 p.m. Friday, April 24.

Preparing for spring storms

As Colorado shifts from winter to summer, spring in Colorado can lead to hazardous storms, so keeping the following safety precautions in mind will help you stay ready and protected.

• Stay connected.

Register for CORE power outage alerts at the Outage Center at www.CORE.coop and your local government emergency alerts. Plan to monitor local weather, news and social media for detailed information during large outages.

• Prepare an emergency kit.

Have an emergency kit ready with essentials such as water, non-perishable food, flashlights, batteries, a first aid kit and any necessary medications.

• Secure outdoor items.

Bring in or secure outdoor furniture, decorations and other items that could become projectiles in strong winds.

• Stay indoors.

During severe weather, stay indoors and away from windows. If a tornado warning is issued, move to a basement or an interior room on the lowest floor of your home.

• Use caution.

If the storm brings heavy, wet snow, take breaks while shoveling to avoid overexertion. Use proper techniques to prevent injury.

• Have a communications plan.

Ensure all family members know how to contact each other in case of an emergency. Designate a meeting place in case you are separated.

• Check home safety devices.

Verify that smoke alarms and carbon monoxide detectors are functioning properly. Ensure first aid kits and fire extinguishers are not expired.
